The Village of Central Square Planning Board met at the Village Hall on September 21, 2017 at 7:00PM. Members in attendance were Chair Maryellen Commisso, Zita Bookman, Craig Wilson, Maggie Kirkby and Mark Monica. Guest present was Millard Murphy, Ed Cusato Jr. and Tim Freitag with Bohler Engineering.

**Called To Order:**

Maryellen called the meeting to order at 7:00PM, all board members were in attendance and was followed by the Pledge of Allegiance.

**Old Business:**

**Maryellen:** We received a letter from Oswego County for the O'Reilly project and they gave the approval. We do need to finish up a few things with the O'Reilly project before we can go on. We need a motion to except the check they gave us back on June 15, 2017 for the escrow account of \$4000.00. Zita made a motion to except and was seconded by Craig Wilson. All were in favor. **Maryellen:** We need to make a resolution on the O'Reilly project, the L&M has come back from the County and everything that has been sent out, it has been filled out and everything is approved along with the permits have being issued and we have the County's approval. We need a resolution that everything has been filed, everything is good to go with O'Reilly and they are all set. Zita made a resolution, seconded by Maggie to go ahead with the O'Reilly project. Motion was carried all in favor. **Maggie:** There should be a recitation that the motion was made and accepted and there should be a resolution paragraph in there that it is here by resolved that the Planning Board accepts the site plan review as presented by O'Reilly. Something to that affect should be made and will have Kim Cusson type it up. **Ed Cusato:** The drawings were all submitted and the final site plan was signed? They have to be signed and stamped and some notation on them that says final drawings accepted. Do you know when you will be starting? **Tim with Bohler:** I am not aware of the time line yet. **Maryellen:** Kim I signed the map and will leave everything on your desk. I wanted to make sure that Tim with Bohler knew how much was left in the escrow account and \$2988.00 has been spent. I thank you Tim for coming to all the meetings.
